Course Structure of Study

The Bachelor of Business comprises of:

- 10 Core subjects
- 8 Subjects in an area of specialisation (major)
- 6 Electives including a Professional Practice unit

To qualify for the Bachelor of Business award a candidate shall accrue at least 240 credit points, including satisfactory completion of the rules noted below:

- Minimum 2 subject (20 credit points) in professional experience

Area of Specialisation (Major)

What is an Elective subject?

If you have completed the requirements of a Specialisation, any additional units completed within the Bachelor of Business is classified as an Elective Subject.

Any unit that is not within the Bachelor of Business award is classified as an Elective Subject. Before enrolling into an elective subject, ensure that you have met the pre-requisite for that unit.

For example, THE320 Theology and Popular Culture is a unit outside of the Bachelor of Business award. You must meet the pre-requisite of 80 credit points and completed THE101 Christian Worldview.
